What is the purpose of the Boise ATV Trail Riders?

The Boise ATV Trail Riders (Club) was started in 1996 by a couple of avid ATV riders to:

- Foster, promote and enhance the use of ATVs for recreational purpose in the State of Idaho.
- Educate, encourage, and promote the safe and responsible use of ATVs.
- Organize and sponsor ATV rides and events.
- Cooperate with public land management and/or regulatory agencies, but always reserving the right to oppose regulations or actions the Association considers unfair and/or not serving the best interest of the members.
- Sponsor the enactment of fair state, federal and private land use laws and regulations pertaining to the ownership and operation of ATVs. To actively oppose such laws and regulations as determined to be detrimental to the best interests of the members.
- Actively seek out and build mutually beneficial relationships with other recreational users of public land.

When does the Club meet?

The Boise ATV Trail Riders meets once a month. Check our website:

How often are the rides planned?

The Club tries to plan at least one ride per month. During the months of March to August, a “clean-up” and/or trail maintenance event is planned. There are optional overnight events planned during the summer. Additional rides are held throughout the year depending on weather, fires, etc. (See website for rides, dates, etc.)

How much does it cost to join?

There are three basic memberships: Individual, Family, and Sponsor/Business with an additional Associate and Honorary classifications:

- **Individual** – A person who engages in recreational ATV use and who subscribes to and supports the purposes of the Club. Must be 18 years or older. \$15 / Year.
- **Family** – An Individual membership plus spouse and unmarried children under 18 years of age. \$20 / Year.
- **Sponsor/Business** – A commercial enterprise that subscribes to and supports the purposes of the Club. \$60 / Year.
- **Associate** – Persons or organizations that do not engage in recreational ATV use but wish to support the Club and/or participate in its social activities. (Non-voting member.) \$10 / Year.
- **Honorary** – Persons worthy of special recognition for activities and accomplishments in furtherance of the purposes and goals of the Club. Must meet specific criteria established by the Board of Directors. (Non-voting member.) No cost.
